Booth Rental Agreement

The Vendor hereby does release, indemnify, and hold harmless St. Andrew's Mission from any claims, demands, causes of action, or damages of any kind or nature against St. Andrew's, its consultants, employees, agents, representatives, or designees. This includes loss, theft, burglary, robbery, and damages to property of any kind, including equipment, supplies, prizes, merchandise, exhibits, etc. of the Vendor or any of its agents, invitees, etc.

No alcoholic beverages, firearms, tobacco products, or drugs are permitted.

The primary Vendor registering for the booth must be 18 years old or older and is responsible for the items and all "helpers" within their booth space. Booths must be manned at all times during the Event by the Vendor or its representatives.

Vendors are responsible for keeping their booth area clean before, during and after the Event.

Be sure to have an adequate amount of change for purchases. Don't forget your Calculator!! ☺

Vendors are not permitted to use trash barrels or dumpsters to discard boxes, unwanted or unsold items.

No concession (food/beverage) items are allowed at any point during the event. There are no exceptions.

The following items are not accepted at this sale: political or religious handouts, pornographic or nude material, and anything viewed by St. Andrew's Mission that is not deemed acceptable to a family audience.

St. Andrew's Mission reserves the right to reject or remove from the sale any items considered unsuitable. Booths found in violation will be closed down.

Booth Set-Up: Booths may be set-up on Thursday and Friday, December 12th and 13th, from 8 am – 5 pm. Please have booth ready to go by Saturday at 7 am!! *The Early Bird catches the worm!!* Vendors may enter through the main entrance of The Mill Event Space. Please **unload your items first**, move your vehicles to the designated parking areas, and **then set-up your booth space**. Spaces will be clearly marked with your Booth # and Name. Areas may be congested during booth set-up. Please be courteous of other Vendors and do not block their access to booths at anytime. All items for sale must be within your booth space.

Booth Break-Down: All Vendors are responsible for cleaning up their entire booth space at the end of the event. All booths must be empty of all contents, unsold items, etc. by 1 pm. Items not removed will become donations to St. Andrew's Mission. A gift receipt will be provided if requested.
